



## Information and Resources to Support Reproductive Health Care Access for Young People with Experience in Foster Care

*The information below is intended to help advocates support young people in foster care navigate reproductive health care and abortion access in their state and includes information to support individual and systemic advocacy.*

### I. State Law, Clinics, and Funding

#### State Law

- **Judicial Bypass Wiki**: This wiki explains parental involvement laws and judicial bypass processes throughout the country. Judicial bypass is the process by which a judge, rather than a parent or guardian, provides permission for a minor to have an abortion.
- **Interactive Map of US Abortion Policies and Access**: This map is frequently updated by the Guttmacher Institute.
- **State Law on Consent to Reproductive Care, Including Abortion**: This is an updated chart, containing information for all states.

#### Abortion Clinics and Funding

- **State by State Guide to Abortion Laws and Clinics**: This is a resource developed by advocates, public health experts, researchers, designers, and engineers and includes state specific information and resources.
- **National Network of Abortion Funds**: Abortion Funds can connect you with local organizations that can identify clinics, funding and arrange for logistical needs.

#### Clinics Providing Reproductive Health Care and Health Care

- Find a **Title X Family Planning Clinic**: Title X Clinics provide family planning services and preventive health services that benefit reproductive health, such as STI and HIV testing, HIV counseling, and HPV vaccines.
- Find a **Community Health Center**: These centers are community-based organizations that deliver comprehensive, culturally competent, high-quality primary health care services, regardless of patients' ability to pay, and charge for services on a sliding fee scale.

### II. Getting Technical Assistance (TA)
