Youth Homelessness Snapshot

- **Research indicates that LGBTQ+ and undocumented/recent immigrant youth are overrepresented amongst youth who experience homelessness.**
- **Common Challenges**
 - Discrimination & Rejection
 - Fear of authorities
 - Trauma & mental health needs
 - Lack of culturally competent services
 - Increasingly hostile laws, policies, and practices.

Common Service Provider Challenges

- **Limited staff resources**
- **Fear/mistrust from youth**
- **Policy Barriers**
- **Fear/uncertainty from staff**
